**Secretarial Compliance Report of Mohit Paper Mills Limited for the financial year ended
31st March 2025**

We, Agarwal S. & Associates, Company Secretaries, have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by Mohit Paper Mills Limited (hereinafter referred as “the listed entity” or “MPML”), having its Registered Office at 15A/13, Upper Ground Floor, East Patel Nagar, New Delhi-110008, India.
